U.S: Myanmar mass-grave report shows probe needed

BALUKHALI REFUGEE CAMP, Bangladesh - The State Department says the world needs to know what happened in the area of Myanmar where The Associated Press has confirmed more than five previously unreported mass graves.

State Department spokeswoman Heather Nauert says Washington is "deeply, deeply troubled" by the report and continues to stand by Secretary of State Rex Tillerson's recent statement that ethnic cleansing has occurred in Myanmar's Rakhine state.

The AP's report confirmed mass graves in the Rakhine state village of Gu Dar Pyin by relying on time-stamped cellphone video and interviews with two dozen survivors. They say Myanmar troops and Buddhist villagers killed scores of ethnic Rohingya Muslims.

Brookfield man charged with Elm Grove porch theft

A Brookfield man was charged Friday after video showed him stealing packages off an Elm Grove porch.

David Krejci, 26, was taken into custody Thursday when a detective saw him driving on Highland Drive in Elm Grove. He was arrested in a parking lot at 13425 Watertown Plank Road. Jason Hennen, assistant chief of police, said Krejci admitted to taking the packages.

Krejci was charged with misdemeanor theft and felony bail jumping.

Surveillance footage shows Krejci knocking on the door of a home in the 14900 block of Marilyn Drive. After no response, he took the packages from the porch and left on foot, the criminal complaint said. Krejci was out on bail for 14 felony drug-related charges in Waukesha County.

Boxing

Canadian boxer Adonis Stevenson is hospitalized in critical condition after being knocked out in his light heavyweight title fight in critical condition.

Boxing promoter Yvon Michel said that Stevenson was in intensive care and that his family asked that his privacy be respected.

Oleksandr Gvozdyk stopped Stevenson at 2:49 of the 11th round Friday night to take his World Boxing Council light heavyweight title.

The 41-year-old Stevenson was put on a stretcher after the bout and left Videotron Center in an Ambulance.

Federer nets Hopman title

Roger Federer won the Hopman Cup for a record third time after defending champion Switzerland beat Germany, 2-1, on Friday in Perth, Australia.

Switzerland took its fourth Hopman Cup title overall when Federer and Belinda Bencic beat Alexander Zverev and Angelique Kerber, 4-0, 1-4, 4-3 (4) in the Fast4 formal in the mixed doubles decider. In the men's singles, Federer defeated fourth-ranked Zverev, 6-4, 6-2. Ahead of his Australian Open title defense, the 37-year-old Federer didn't drop a set in four singles matches at the tournament, beating Frances Tiafoe, Stefanos Tsitsipas, Cameron Norrie, and Zverev.

Switzerland won the third-set tiebreaker in the mixed doubles after Zverev hit the ball into the net.

Wisconsin strip club reaches settlement with dancers

MADISON - A Wisconsin strip club has agreed to pay \$400,000 to settle dancers' claims that they were paid essentially nothing for their performances.

Teriana Jones, who worked as a stripper at Cruisin' Chubbys Gentleman's Club, filed a federal class-action lawsuit in 2018 alleging club managers required dancers to share tips to such an extent that dancers weren't paid minimum wage or overtime. The class includes about 109 dancers.

The club and the strippers filed a proposed settlement filed a proposed settlement Thursday. The deal calls for the club to pay the strippers and their attorneys \$400,000. The attorneys will receive \$136,000. The dancers will divide \$245,700. Jones will get an additional \$10,000 and fellow dancer


get an additional \$10,000 and fellow dancer Bethany Morrisey and additional \$8,000 for acting as class representatives.

Blast kills three in Somali restaurant

Hargesia, Somalia - A bomb explosion at a restaurant in the Somali capital, Mogadishu, killed three people and injured more than 16 others on Saturday, a Somali police officer said. The bomb is believed to have been concealed in the restaurant often frequented by government soldiers in Hodan district, Capt. Mohamed Hussein said.

There was no immediate claim of responsibility for the bombing, but suspicion centered on the Islamic extremist group al-Shabab, which has waged an insurgency against Somalia's weak government. Al-Shabab, al-Qaida's East African affiliate, is fighting to impose a strict version of Islam in the Horn of Africa nation.



House OKs bill banning slaughter of cats, dogs for food

WASHINGTON - The House had passed legislation that would outlaw the slaughter of dogs and cats for food - a practice that, although rare, is still legal in 44 states. The bipartisan bill by Florida Reps. Vern Buchanan, a republican, and Alcee Hastings, a Democrat, would amend the federal Animal Welfare Act to ban the slaughter of dogs and cats for human consumption in the United States. It was passed Friday by voice vote.

The bill makes it illegal to knowingly slaughter, transport, possess, buy, sell, or donate dogs or cats or their parts for human consumption. Violators would be fined up to \$5,000.

Buchanan said he is optimistic the Senate will pass the Dog and Cat Meal Trade Prohibition Act before the end of March.

Instagram famous firehouse cat get stuck in drain pipe

GREENVILLE, S.C. — A stray cat that made a home of a South Carolina fire department and became Instagram famous got himself stuck in a drain pipe beneath the station. The Greenville News reports Flame, also known as "Arson Cat," was found late Wednesday in a 12-inch (30-centimeter) storm drain that runs about 50 feet (15 meters) beneath the station's parking lot.

Lt. Brandon Peskopos says the station's assistant chief was calling for the missing Flame and heard a sound coming from the drain. Off-duty firefighters went after him and rescued the damp cat. It's unclear how Flame got into the pipe.

The orange and white cat wandered into the fire station about three years ago and stole the hearts of firefighters. They later started an Instagram for him that's gained 100,000 followers.

MINING: Minnesota approves major state permits for mine

State pollution regulators on Friday issued the last major state permits sought by the developers of the planned PolyMet copper-nickel mine in northeastern Minnesota. The Minnesota Pollution Control Agency announced its approval of the air- and water-quality permits for the project and a certification that the company's plan to mitigate the mine's impact on wetlands will meet state water quality standards. The only remaining major permit is a wetlands permit from the U.S. Army Corps of Engineers. Several environmental groups have sued to block the permit decisions, saying the mine near Babbitt would threaten water quality downstream. Babbit is about 100 miles north of Superior, Wisconsin.

Man sought in workplace machete incident

FRANKLIN - a 49-year-old Milwaukee Man is wanted by Franklin police after he allegedly attempted to enter a manufacturing a building with a 3-foot machete following an argument with one of its employees, his son.

An arrest warrant was issued Friday for Angel A. Rivera-Vargas, according to online court records, on a misdemeanor charge of disorderly conduct with a dangerous weapon.

According to a criminal complaint, Rivera-Vargas and his wife were driving their 24-year-old son to his job at Innovative Fiber. An argument between Vargas and his son cam to a head when the car entered the parking lot.

Rivera-Vargas slammed on the brakes, exited the car and began rummaging through the trunk. The son knew his father keeps a 3-foot machete in the trunk, so he ran over to his father and preemptively punched him in the face, knocking him to the ground.

The father then grabbed a metal steering wheel lock and chased the son around the parking lot, just as another car pulled in. The driver of that car picked him up and drove away. Rivera-Vargas attempted unsuccessfully to enter the building with the machete. He then drove away before police arrived.

Manitowoc officer's deadly force justified, district attorney says

MANITOWOC - Authorities say a Manitowoc police officer's actions were justified when he shot and killed a man in October, Manitowoc County District Attorney Jacalyn LaBre said in a report released Friday.

Officer Fielder Clark was responding to a fire alarm in Manitowoc when he was confronted by Bruce Smith, 25, who was armed with what was later described as a metal paint scraper. Authorities say Clark then shot Smith. He died at the scene.

LaBre said Clark was given very little time to make the decision to use deadly force and the officer's "conduct was lawful."

Manitowoc Police Chief Nick Reimer said Clark will be restored to active duty immediately. Reimer called the shooting a "tragedy all around."

Pope cuts 2 cardinals named in abuse scandal from his cabinet VATICAN CITY - Pope Francis has removed two cardinals from his informal cabinet after they were implicated in the Catholic Church's sex abuse and cover-up scandal. The Vatican said Friday that Francis in November had written to Chilean Cardinal Javier Errazuriz and Australian Cardinal George Pell thanking them for their five years of service on the so-called Group of Nine, or C-9. Their continued presence on the C-9 had been a source of scandal for Francis, given the explosion of the abuse and coverup crisis this year.

Tennis

Serena Williams overcame a sluggish start to power past Maria Sakkari in straight-sets at the Hopman Cup in Perth, Australia, on Monday in her first competitive match since melting down in the U.S. Open final.

The 37-year-old was rusty and down an early break but did enough to record a comfortable 7-6 (3), 6-2 victory in one hour and 44 minutes. The result leveled the match between the United States and Greece, but Williams and playing partner Frances Tiafoe later lost the mixed doubles match in three sets to Sakkari and Stefanos Tsitsipas. Even though both her ankles were strapped and required medical attention during the change of sets, Williams moved freely and looked sharper as the match wore on.

Prosecutors want trial date in Florida school shooting

FORT LAUDERDALE, Fla. -

Prosecutors pushed a judge Friday to set a trial date this fall for Nikolas Cruz in the 2018 Valentine's Day Florida high school massacre that killed 17 people.

At a hearing, Assistant State Attorney Jeff Marcus said the case is fairly uncomplicated despite its notoriety and magnitude. He asked Circuit Judge Elizabeth Scherer to schedule the death penalty trial for Cruz in September.

Judge Scherer, however, said she is reluctant to move that quickly, with Cruz's lawyers contending they still have large amounts of evidence to review and dozens of witnesses to interview. Assistant Public Defender Melisa McNeil said there are more than 300 witnesses on the prosecution's list and added that capital cases in Broward County typically take two years or more to get to trial.

MLB, Cuba strike deal

Major League Baseball and the players association announced Friday they've reached an agreement with the Cuban government to allow players from the island to be scouted and signed by the league without having to defect.

The deal facilitates Cuban players' entry into American professional baseball while avoiding the dangerous journeys and dealings with human smugglers that have marked many of their departures.

For decades, Cuban players have risked their lives and the possibility of jail time if caught by escaping from their homeland in furtive boat trips to destinations like Mexico, Haiti or the Dominican Republic, where they could establish residency and pursue multimillion-dollar contracts.

All-stars such as Mets outfielder Yoenis Cespedes, Dodgers outfielder Yasiel Puig and White Sox first baseman Jose Abreu made it out that way, although details of their escapes have been sketchy because of fear their relatives may face retribution back home.

At the beginning of last season, there were 17 natives of Cuba on major-league rosters and disabled lists, the fourth-largest contingent of foreign-born players in the game.

Russia: 5 dead in church shooting

Makhachkala, Russia - A gunman opened fire with a hunting rifle on churchgoers leaving a service in Russia's Dagestan region, killing five people and wounding four others, then was shot and killed by police, authorities say.

The shootings took place Friday evening in Kizlyar, a town of about 50,000 people on the border with Chechnya.

Four people died at the scene and a fifth died at a hospital, regional Interior Ministry spokesman Ruslan Gadzhiibragimov said. The gunman was a local resident, and his wife has been detained for questioning, he said.

The motive for the attack was not immediately known.

Dagestan is a predominantly Muslim region between Chechnya and the Caspian Sea. Following two separatist wars in neighboring Chechnya, and Islamist insurgency spread to Dagestan.

Franklin business owner arrested after remains found in East Troy

Franklin police have arrested a 43-year-old Franklin man in connection with the discovery of human remains in a burn pit on a rural Walworth County property.

The suspect, who has not yet been names, was taken into custody under suspicion of first-degree intentional homicide, the Franklin police news release said.

The release described him as a Franklin business owner who has charges pending in multiple jurisdictions.

Police determined the suspect was connected to the disappearance of two people, the release said. After executing a search warrant on an East Troy-area farmhouse, which the suspect leases for hunting, officers discovered human remains in a burn pit.

Police are still identifying the remains.

An arson investigation by the Milwaukee Police department led to the report of two missing people, the release said.

At least 18 unmarked vehicles and two mobile command center could be deen Friday at the property near Woodfield Court and Highway J in East Troy.

The Walworth County Sheriff's Department, the village of East Troy Police Department, the Milwaukee Police Department, and the Waukesha County Medical Examiner's Office are assisting with the investigation.

Handcuffed man shot multiple times by Green Bay officer

GREEN BAY - Jonathan C. Tubby was handcuffed and unarmed when he was shot and killed by a Green Bay police officer at the Brown County Jail this fall, according to sources familiar with the shooting.

Tubby was shot five times "as he moved in the direction of" an officer, who likely could not tell that Tubby was unarmed, the sources said. Police have identified Erik O'Brien, a sixyear veteran, as the officer who shot Tubby.

Authorities investigating the case have made no official statements about the Nov. 19 shooting of the 26-year-old, who was in custody after being arrested in downtown Green Bay on a warrant. But interviews with four people with knowledge of the case paint a picture of Tubby, hands cuffed in front of him, refusing to cooperate with officers who had driven him to the sally port of the jail at 3030 Curry Lane. The sally port is an enclosed garage-like area where officers park to walk their prisoners into the jail to be fingerprinted and booked.

The sources were interviewed, on different days and at different locations, but independently provided nearly identical accounts.

At least 12 die in Bronx apartment building fire

NEW YORK - Twelve people were killed and four more were seriously injured and fighting for their lives late Thursday in a fast-moving fire at an apartment building on a frigid night in the Bronx, New York City's mayor said.

The victims included a child around a year old, Mayor Bill de Blasio said during a briefing outside the building.

"We may lose others as well," he said.

Fire Commissioner Daniel Nigro called the fire "historic in its magnitude" because of the number of lives lost.

The blaze broke out at a five-story building, a block from the grounds of the Bronx Zoo. About 170 firefighters worked in bone-chilling cold, just 15 degrees, to rescue people from the building.

Neighborhood resident Robert Gonzalez, who has a friend who lives in the building, said she got out on a fire escape as another resident fled with five children.

"When I got here, she was crying," Gonzalez said.

"The smoke was crazy, people screaming, 'Get out!," a witness, Jamal Flicker, told the New York Post. "I heard a woman yelling, 'We're trapped, help?"

Israeli officer kills Jordanian attacker

Jerusalem - An Israeli police officer shot dead a Jordanian attacker who stabbed him in the Old City of Jerusalem on Friday, police said, in a rare incident that sparked tension between the two nations.

Police spokeswoman Luba Samri said the attacker quickly pulled a knife and stabbed the officer several times, moderately wounding him. Samri said the officer responded by opening fire and killing his attacker, a 57-year-old man from Jordan who arrived on a tourist visa. Closed circuit footage released by a police shows a bald man in a jacket lunging at the uniformed officer and swiping a knife at him before pinning him to the ground.
