## **Hurley School Board votes to drop Midget mascot**

Come fall, students in the Hurley School District won't be cheering on its longtime mascot, the Midget.

They Hurley School Board had planned to let voters weigh in on the issue in an April referendum, but Thursday, the board changed course and voted to discontinue the use of the mascot at the end of this school year.

The board said in a statement, "The Hurley School Board has been wrestling for some time with the future of the Hurley Midget mascot. To be sure, this is the most difficult decision any of us has ever made as board members."

The school board said it changed its mind on how to tackle the mascot issue because it didn't want to divide the community.

"We wanted to avoid any situations in which neighbors would be pitted against neighbors in a divisive and disruptive way. We fully understand that many in the community will disagree with this vote, but we felt the need to take action," the board said in a statement. Hurley's mascot is decades old and had been a source of Community pride. However, Hurley School District Administrator Chris Pattrito said that he and other board members have fielded complaints from alumni in the last dozen years or so.

The mascot name is widely considered offensive among people with dwarfism and their families and friends.

Ultimately, the school board felt the mascot sent the wrong message to students and families.

Pattrito said, "I couldn't really tell you the backstory. The best story I heard about the 'midget' was that many moons ago we were playing in a state tournament and we had a lot of short Italian miners and one of the radio announcers said they looked like midgets."

The board will begin the process for choosing a new mascot with community and student input.

## **Man in custody of homicide of woman found in parking garage**

A 27-year-old man is in custody in the homicide of a 33-year-old woman found frozen and trapped under a car in the parking garage at Froedtert Hospital Friday, the Milwaukee County Sheriff's Office said. Sheriff's officials arrested the man near North 37th Street and West Wisconsin Avenue after receiving a tip.

In an email to employees of Froedtert & the Medical College of Wisconsin, the hospital said:

"We are so very sad to share with you that the individual who passed away this morning was a member of our MCW and Froedtert Hospital family. We ask for your support of one another and of those grieving this loss."

A sheriff's deputy found the woman trapped on the top level of the west parking garage. Her head was bleeding profusely, according to Faithe Colas, spokeswoman for the sheriff's office. The woman died less than an hour after authorities arrived at 3:43 a.m.

Colas said the car had crashed into a wall of the parking structure and had moderate damage. No one else was inside the car.

The Wauwatosa Fire Department attempted to free the woman, who was frozen to the ground. Paramedics said she had a weak pulse and was unconscious, Colas said.

She was taken to Froedtert, where she was pronounced dead at 4:21 a.m., Colas said.

The case is expected to be presented to the Milwaukee County District Attorney's Office.

## **Giannis Antetokounmpo sues over remodeling**

Milwaukee Bucks star Giannis Antetokounmpo has already been a plaintiff in a lawsuit of the kind you expect a celebrity athlete might have to file, to protect his trademarked nickname, Greek Freak. Now the reigning MVP of the NBA apparently has the same kind of consumer problem regular folks can relate to: He's suing a contractor he says didn't live up to his home remodeling promises.

According to the lawsuit:

Antetokounmpo hired David I. Gonzalez of Cedarburg, and his companies DIG Enterprises and Antidel & Son Construction Co. a year ago to do a variety of renovations at Antetokounmpo's River Hills home. The work included painting, installing new countertops, a shoe closet and flooring, landscaping and fencing.

The contract called for a \$40,000 down payment on a total bill expected to top \$238,000.

But some work was never done and other work wasn't done correctly, according to the suit. In particular, Antetokounmpo claims, Gonzalez fraudulently obtained more than \$144,000 just for the fence project and didn't install the fence or even get the necessary permits.

The suit says Antetokounmpo gave Gonzalez chances to repair problems, return money and settle the matter before suing Monday.

Gonzalez did not return a reporter's phone call Wednesday.

The lawsuit lists five claims: breach of contract, breach of implied covenant of good faith, unjust enrichment, fraudulent representation and theft by contractor.

Antetokounmpo is looking to recover unspecified actual damages, plus three times that amount in exemplary damages, plus the costs of litigation.

## **2 arrested after 65-mile chase through 10 communities**

A 65-mile police chase through Milwaukee and nine suburbs began with an incident in Waukesha that injured one officer and ended when two suspects were arrested in West Allis after their vehicle crashed. The chase began in Milwaukee, where police located the suspect vehicle shortly before 11:30 p.m. Friday while assisting the Waukesha Police Department in its investigation.

Two hours earlier in Waukesha, a violent struggle broke out between a wanted male suspect and two male officers in the 2100 block of East Moreland Boulevard. Police said they had received information that the suspect was part of a plan to steal clothes. Authorities located two people, a female driver and a male passenger, inside a vehicle and asked the male occupant to step out. A struggle ensued after the male pushed the female out of the driver's seat and began fighting with officers as they tried to pull him out of the vehicle, police said.

He struggled free, got into the driver's seat, and sped off, running over one officer and knocking down another, police said.

When the vehicle was spotted two hours later in Milwaukee, the 64.9-mile chase began, running south and west through Cudahy, St. Francis, Greendale, Greenfield, Hales Corners, West Allis, and West Milwaukee.

The vehicle crashed at the National Avenue exit of Interstate 41, injuring both occupants, who were taken to a hospital with non-life-threatening injuries. The Waukesha police officer who was run over was also taken to a hospital but was later released. Waukesha and Milwaukee police said the investigation is continuing. Names of the suspects were not released pending the filing of charges.

## **Bill would require diaper-changing stations in more public restrooms**

MADISON - New legislation is meant to end a diaper disparity.

Under a bill by three Milwaukee Democrats, public buildings and commercial buildings would have to have diaper-changing stations available to both men and women.

Rep. Jonathan Brostoff said he was introducing the legislation because he found some establishments have diaper-changing stations in women's restrooms but not men's restrooms. He became familiar with the issue as he toted his 9-month-old son, Boaz, from place to place.

"A lot of the establishments I was going into, it was only the guy's bathrooms (that didn't have changing stations)," Brostoff said. "The women's bathroom did actually have it. I thought that was kind of weird."

He's working on the legislation with Sen. Chris Larson and Rep. David Crowley, who are running against each other in a crowded field for Milwaukee County executive.

Brostoff said he hoped Republicans who control the Legislature would sign onto the bill, noting similar measures have passed in red states.

"It's not a Democratic or a Republican thing. It's a parent thing," he said.

The legislation would require public buildings and commercial buildings with restrooms open to the public to have diaper-changing stations that are available in both men's and women's bathrooms or in gender-neutral bathrooms.

The legislation would also require building owners to post signs about where the stations are located.

## **Man arrested in death of reputed crime family boss**

NEW YORK - Police say they arrested Anthony Comello, 24, in the shooting death earlier this week of reputed crime boss Francesco "Franky Boy" Cali.

Officials said Camello was in custody in New Jersey pending extradition to Staten Island, New York, to face murder charges.

NYPD Chief of Detectives Dermot Shea said police were still working to determine the suspect's motive and whether he was working with ot for other people.

"We are well aware of Mr. Cali's past. That will be a part of this investigation as we determine what was the motive for the incident on Monday evening," Shea said.

Comello was being held at the Ocean County Jail on a murder count, according to authorities.

Cali, 53, died at a hospital after being shot multiple times in the torso in front of his home in Staten Island. Police found Cali wounded after receiving a 911 call reporting an assault about 9:15 pm.m Monday.

Federal prosecutors in Brooklyn had referred to Cali in court filings in recent years as the underboss of the Gambino organization, related through marriage to the Inzerillo clan in the Sicilian Mafia.

His murder marked the most notable killing of a Gambino boss since 1985, when Paul Castellano was shot deas in front of the Sparks Steak House in Manhattan. Cali lived less than a half-mile from Casellano's Staten Island Mansion.

## **McDonald's CEO steps down after relationship with employee**

NEW YORK - McDonald's chief executive officer has left the company after violating company policy by engaging in a consensual relationship with an employee, the corporation said Sunday. The fast food giant said former president and CEO Steve Easterbrook demonstrated poor judgment. McDonald's forbids managers from having romantic relationships with direct or indirect reports.

In an email to employees, Easterbrook acknowledged he had a relationship with an employee and said it was a mistake.

"Given the values of the company, I agree with the board that it is time for me to move on," Easterbrook said in the email.

McDonald's board of directors voted on Easterbrook's departure Friday after conducting a thorough review. Details of Easterbrook's separation package will be released Monday in a federal filing, according to a company spokesperson. Easterbrook was CEO since 2015. The board of directors named Chris Kempczinski, who recently served as president of McDonald's USA, as its new president and CEO.

Two weeks ago, McDonald's reported a 2% drop in net income for the fourth quarter as it spent heavily on store remodeling and expanded delivery service. The company's share price has dropped 7.5% since, though it's still up 9.2% for the year. The leadership transition is unrelated to the company's operational or financial performance, the company said in a news release.

## **San Francisco reins in tests of tech ideas on streets**

San Francisco - Tired of San Francisco streets being used as a testing ground for the latest delivery technology and transportation apps, city leaders are requiring businesses to get permits before trying out new high-tech ideas in public.

Supporters of the legislation, which the Board of Supervisors unanimously approved Thursday, say it is the first of its kind in the U.S. They say it's long overdue in a city that's a hub for major tech companies but is more accustomed to reacting to the sudden arrival of new technology - such as when hundreds of dockless electric scooters appeared seemingly overnight last year.

The e-scooter trend led to complaints from people in cities across the country.

The tech industry showered San Francisco with high-paying jobs and cemented its reputation as a place for big ideas, but the success of homegrown companies Airbnb, Lyft, and Uber has vexed some residents as streets have become more congested and the housing shortage has worsened.

The Office of Emerging Technology will serve as a one-stop shop for entrepreneurs who want to test their products in San Francisco's public space.

Companies will not be allowed to experiment unless the office declares the tech in question a "net public good."

It's not clear how criteria will be used to evaluate proposals, but companies that share data, ensure public safety and privacy when testing, and promote job creation would have an advantage.

## **FCC moves to make 988 suicide hotline number**

WASHINGTON, D.C. - Federal regulators are setting up a new three-digit number to reach a suicide prevention hotline in order to make it easier to seek help and reduce the stigma associated with mental health.

Once it's implemented, people will just need to dial 988, similar to calling 911 for emergencies or 311 for city services.

Currently, the National Suicide Prevention Lifeline uses a 10-digit number, 800-273-TALK (8255). Callers are routed to one of 163 crisis centers, where counselors answered 2.2 million calls last year.

"The three-digit number is really going to be a breakthrough in terms of reaching people in a crisis," said Dwight Holton, CEO of Lines for Life, a suicide prevention nonprofit. "No one is embarrassed to call 911 for a fire or an emergency. No one should be embarrassed to call 988 for a mental health emergency."

A law last year required the Federal Communications Commission to study assigning a three-digit number for suicide prevention. The FCC said in a report that there is overwhelming support for a three-digit number because it would be easier for distressed people to get help.

Thursday's vote starts the months-long process to make that happen. The next step is a comment period before the FCC moves to an order.

## **Armed grandmother abducted 12-year-old girl from hospital**

A 12-year-old girl allegedly abducted by her grandmother has been found unharmed, authorities in Louisiana said Friday evening.

The suspect, Evelyn Miller, 66, was arrested on suspicion of kidnapping by local law enforcement about 5 p.m. at a hotel in Bogalusa, about 70 miles north of New Orleans, said Sheriff Joseph Lopinto of Jefferson Parish.

The girl was found "during the arrest," the Jefferson Parish Sheriff's Office said in a statement.

The alleged kidnapping was reported about early Thursday evening at a medical facility in Jefferson Parish, the office said in an earlier statement.

"Evelyn Miller entered Adreana's hospital room to remove her from the hospital," the statement said.

"When hospital staff attempted to prevent her from leaving with the child, she pointed a firearm at several of them. In making her escape from the location, she pushed one nurse to the ground and struck a security guard with her vehicle."

No injuries were reported. Authorities didn't reveal why the girl was at the facility.

Miller, 66, was armed with a revolver, authorities said. The 2019 Toyota Sienna minivan she was driving was recovered earlier, Louisiana State Police said.

The girl was the subject of a statewide "child endangerment alert," authorities said.

It wasn't clear what motivation, if any, was being ascribed to the suspect. Sheriff's officials said there was an arrest warrant out for Evelyn Miller for kidnapping, aggravated assault with a firearm, battery and violating a firearm-free zone.

## **Engineer says airline opened logs after crash**

Ethiopian Airlines' former chief engineer says in a whistleblower complaint filed with regulators that the carrier went into the maintenance records on a Boeing 737 Max jet a day after it crashed this year, a breach he contends was part of a pattern of corruption that included fabricating documents, signing off on shoddy repairs and even beating those who got out of line. Yonas Yeshanew, who resigned last fall and is seeking asylum in the US, said that while it is unclear what, if anything, in the records was altered, the decision to go into them at all when they should have been sealed reflects a government-owned airline with few boundaries and plenty to hide.

“The brutal fact shall be exposed: Ethiopian Airlines is pursuing the vision of expansion, growth and profitability by compromising safety,” Yeshanew said in his report, which he gave to The Associated Press after sending it last month to the US Federal Aviation Administration and other international air safety agencies.

Yeshanew's criticism of Ethiopian's maintenance practices, backed by three other former employees who spoke to AP, makes him the latest voice urging investigators to take a closer look at potential human factors in the Max saga and not just focus on Boeing's faulty anti-stall system, which has been blamed in two crashes in four months.

“It's not a coincidence,” he said, “that Ethiopian saw one of its Max planes go down when many other airlines that fly the plane suffered no such tragedy.”

Ethiopian Airlines portrayed Yeshanew as a disgruntled former employee and categorically denied his allegations, which paint a blistering counterpoint to the perception of the airline as one of Africa's most successful companies and a source of national pride.

## **Armed police and troops storm El Salvador's parliament**

Armed soldiers and police officers accompanied El Salvador's President Nayib Bukele as he stormed the nation's parliament on Friday afternoon.

The president demanded that opposition lawmakers vote to approve his plan to secure a \$109 million loan that he says would be used to better equip military personnel and law enforcement officers in their job of tackling out-of-control gang violence in the country.

Tensions had been on the rise between the president and opposition lawmakers over the loan, which is intended to finance the third phase three of the so-called Territorial Control Plan. This plan includes additional resources to provide the police and army with better tools to combat crime in El Salvador.

At the time of his election, Bukele was seen by many as an outsider, populist candidate, who campaigned on slogans criticizing those who'd come before him, such as "there's enough money when nobody steals" and "return what was stolen," referring to the alleged disappearance of funds during the administrations of former presidents Francisco Flores and Antonio Saca.

Lawmakers had previously failed to reach an agreement on Bukele's proposal because of concerns about the size of the loan and the president's justification of some of the expenses that he had included in the application for the loan. After storming the parliament, Bukele said a prayer from a seat normally occupied by the president of the parliament, Mario Ponce. Before leaving the building, Bukele gave lawmakers one week to approve his loan proposal.

## **9 Americans brutally killed in Mexico**

At least nine people - three mothers and their children - from a prominent Mormon family were brutally killed in an attack by gunmen in Mexico. Security Minister Alfonso Durazo confirmed the attack in a tweet Friday.

Although authorities in Mexico have yet to confirm many details about the gunmen, relatives suspect that the attack may have been a case of mistaken identity by drug cartels.

The victims were all U.S. citizens and members of La Mora, a settlement about 70 miles south of Douglas, Arizona.

Leah Staddon, a relative who grew up in the same Mormon community before moving to Arizona, said Thursday that she was still trying to get more information about the attack.

Staddon told The Arizona Republic that three mothers were driving from Bavispe to a wedding in LeBaron, another Mormon community in the state of Chihuahua, when their three vehicles loaded with children were attacked. One of the vehicles exploded in flames.

She was still trying to verify late Thursday from relatives in Mexico exactly how many people had been killed.

According to Stadden, three mothers and six children died in the attack. She identified the mothers as Rhinita Miller, Dawna Langford, and Christina Johnson.

Staddon said 33-year-old Miller, who was her nephew's wife, and four of her children died in the blaze.

Langford, Staddon's sister-in-law, and two of her children died in the attack. She was traveling in the second vehicle with nine children.

## **Missing more than a year, an abandoned 'ghost ship' washed ashore on the other side of the Atlantic**

A "ghost ship" abandoned for over a year and drifting in the Atlantic finally washed ashore in Ireland amid Storm Dennis' choppy water, the country's coast guard says.

The MV Alta was found on the coast near Ballycotton, a small town in southern Ireland's County Cork, with no crew on board, the Irish Coast Guard said Sunday.

The county's local council asked the public to stay away from the vessel as crews work to determine whether it poses any environmental risk. The council said "no visible pollution" has been identified, and a team was expected to board the ship Tuesday.

The roughly 250-foot vessel was abandoned in October 2018 after the U.S. Coast Guard rescued its stranded crew that was without power, Lt. Amanda Faulkner, a public affairs officer for the U.S. Coast Guard's 5th District, told USA TODAY.

The cargo ship, flying under a Tanzanian flag, was roughly 1,300 miles southeast of Bermuda when the U.S. Coast Guard received the distress call in September, Faulkner said. The ship's owner planned to send a tug to rescue it, and the Coast Guard airdropped supplies to the crew in the meantime.

"When it became apparent the ocean going tug wasn't going to work out, that's when we sent the rescue crew," Faulkner said. Due to poor weather and the MV Alta's configuration, the U.S. Coast Guard could not tug the boat, so it brought the 10-member crew to Puerto Rico and left the vessel afloat, Faulkner said.

Cork County Council said it was consulting with the Irish Coast Guard and the country's receiver of wrecks, an official who tends to wrecked ships, to determine MV Alta's future.



## **A second monarch butterfly conservationist has been found dead in Mexico**

The body of a second butterfly conservationist and activist has been found in Mexico, authorities said.

Raúl Hernández Romero, a part-time guide and conservationist at Mexico's largest monarch butterfly reserve, was discovered dead Thursday in the Mexican state of Michoacán, local authorities said in a statement released Friday.

He was found with "blunt blows on different parts of the body and a head injury, caused by a sharp object," the statement said.

Romero was reported missing by relatives hours before his body was found. His wife said he was last seen February 17 leaving his home in San Pedro Libertad, according to officials.

He is the second butterfly activist to be found dead in less than a week.

The body of Homero Gomez Gonzalez was found Monday in a retention pond, also in Ocampo. He also had a head injury and died of drowning, authorities said. He had been missing since February 12.

Gomez, known as the Defender of the Monarch Butterfly, might have come into conflict with illegal loggers while carrying out his conservation work, Mexico's State Commission for Human Rights said.

Michoacán state is home to the Monarch Butterfly Biosphere Reserve, a UNESCO World Heritage Site in a forested area about 62 miles outside Mexico City. Every autumn, as many as a billion monarch butterflies migrate to the site from as far north as Canada as part of an eight-month migration cycle.

## **Djokovic will play for title**

Novak Djokovic was about as perfect as can be in his semifinal at Rod Laver Arena. Didn't miss much. Almost couldn't, really.

It was a performance so flawless, so fantastic, that it was easy to feel as if only one man on the planet might have a chance of preventing Djokovic from claiming a record seventh Australian Open title: Rafael Nadal. As it happens, that is who he'll face in Sunday's final.

Djokovic never relented, not for a moment, while making an unheard-of total of five unforced errors against an overmatched Lucas Pouille en route to a 6-0, 6-2, 6-2 semifinal victory that lasted less than 1½ hours.

"I guess you're driven by some force that takes over you, and you feel divine. You feel like in a different dimension," Djokovic said. "It's quite an awesome feeling that we all try to reach and stay in. Probably the biggest challenge, I think, is how to repeat that, how to stay there for as long as you possibly can."

This was as good as he gets. As good as it gets.

"When he's playing like this," the 28th-seeded Pouille said, "yeah, he's the best in the world, for sure."

Now Djokovic will line up against his old rival, Nadal, for the 53rd time on tour, eighth in a Grand Slam final.

It will be the No. 1-ranked Djokovic — owner of 14 Grand Slam titles, including the past two — against No. 2 Nadal, who's won 17 majors. Roger Federer, with 20, is the only man whose total is higher.

He holds a 27-25 edge over Nadal in their head-to-head series; Nadal leads 4-3 in Slam finals. The only other time they met with the Australian Open trophy on the line, in 2012, Djokovic won 5-7, 6-4, 6-2, 6-7 (5), 7-5 in 5 hours, 53 minutes, making it the longest Grand Slam title match in history.

## **Christian Yelich reiterates he's on board with Brewers' plan to shift him from right field to left**

Christian Yelich said at “Brewers On Deck” late last month that he would be on board with moving from right field to left this season if it was determined that was what would be best for the team.

On Thursday, a day after manager Craig Counsell announced that, indeed, Yelich would be playing left this season with Avisail García and Ryan Braun focusing on right, the 2018 National League MVP reiterated his stance.

Yelich bounced all over during his first five seasons in Miami but had his best success in left in 2014, when he won a Rawlings Gold Glove award after posting a .993 fielding percentage and being credited with 13 defensive runs saved in 133 starts.

Yelich posted a .983 fielding percentage and posted minus-3 defensive runs saved in right last year.

Of all García’s physical tools, his strong throwing arm is right at the top of the list so getting him in right field – where the longest throws typically are made – makes sense. Yelich’s throwing arm profiles as average, which plays better in left.

Seeing Yelich and Braun – both former MVPs – being so open-minded about switching positions and doing what’s best for the team might be surprising on the surface.

But the Brewers have tried to make the most of their versatility during Counsell’s tenure, and having two faces of the franchise buying in speaks volumes.

“Everybody is moving around. It's what we do,” Yelich said. “Positional versatility is about a common goal of helping the team win and helping Counsell put the best lineup out there every night, offensively and defensively. This falls along those lines and I'm cool with it. I've been cool with it from the beginning.”

## **Former Packers defensive coordinator Dom Capers joining Vikings as a senior defensive assistant**

Dom Capers, a former head coach of the Panthers and Texans, will join the Vikings staff as a senior defensive assistant.

The 69-year-old Capers is a familiar face in the NFC North – he was the Packers defensive coordinator from 2009-17, including their Super Bowl XLV title following the 2010 season.

Vikings coach Mike Zimmer, who calls the defensive plays, recently promoted linebackers coach Adam Zimmer and defensive line coach Andre Patterson to co-defensive coordinators. They replaced George Edwards, whose contract expired.

Capers has coached in the NFL for 33 seasons, and was Jacksonville's senior defensive assistant last season.

He was head coach of expansion Carolina from 1995-98 and expansion Houston from 2001-05. He also has been defensive coordinator for the Steelers (1992-94), the Jaguars (1999-2000) and the Dolphins (2006-07).

As an expansion team, the Panthers were 7-9 in 1995 before going 12-4 in the second season and losing to the Packers in the NFC Championship Game. Capers was fired after a 4-12 season in 1998.

He was named head coach of the Texans for their first season, 2001, but went 18-46 in four seasons before he was let go. Gary Kubiak, the Vikings new offensive coordinator, succeeded Capers as head coach in Houston and led the Texans for the next eight years.

## Badgers hold on to top Purdue 69-65

Wisconsin built its lead over Purdue behind the 3-point arc. The Badgers secured the win at the free throw line.

Aleem Ford scored a career-high 19 points and the Badgers hit eight straight free throws with less than 30 seconds left to hold off a late charge from Purdue and win 69-65.

It marked Wisconsin's fourth win in five games since Kobe King, who had been the team's leading scorer in conference play, officially announced he was leaving the program.

Wisconsin coach Greg Gard said the run has been marked by different guys stepping up. Brad Davison scored his own career-high with 30 points in a win Saturday on the road against Nebraska, while Ford had just three points that game.

Wisconsin (16-10, 9-6 Big Ten) built a lead in the second half with strong shooting behind the 3-point arc, hitting 11 of its first 23. When Ford knocked down his final 3-point midway through the period, the Badgers were up 51-38, and Noel Eastern's foul on the next Purdue possession put Wisconsin into the bonus.

But Wisconsin then missed seven of its next eight 3-point attempts. When Eastern converted a three-point play with 2:34 left, Purdue had trimmed Wisconsin's lead to 59-56. Later trailing 61-59, Sasha Stefanovic had two 3-point attempts with less than a minute left that would've given the Boilermakers the lead. But both came up empty, and Davison and Brevin Pritzl each hit all four of their ensuing free throw attempts to seal the win.

Davison and Pritzl each scored 13 for the Badgers and Nate Reuvers added 12. The Badgers finished 19 of 20 from the foul line for the game to overcome 38% shooting (19 of 50) from the field.

Purdue outrebounded Wisconsin 37-30 and its 19-12 edge in second-chance points helped offset another mediocre shooting performance on the road.
