# **COVID PROTOCOL RECOMMENDATIONS**

In order to return to in-person forensic tournaments, many school districts require that COVID mitigation practices are in place. Some districts continue to have mask requirements and other strict policies, and without similar requirements in place at tournament sites, those schools may not be allowed to participate.

For these reasons, the WFCA published these **recommendations** for all in-person tournaments. Adoption and enforcement of these policies is highly recommended for tournament hosts. WFCA also requests that all tournament hosts include in their invitations and registration information that the WFCA COVID mitigation requirements will be in effect at their tournaments.

If other COVID related policies will be in effect instead of or in addition to those published by WFCA, please include that information in all invitations and registration information. If transmission rates in Wisconsin change during our season, these requirements may change accordingly.
